

SUMMARY ANNUAL REPORT

For Schreiber Foods, Inc. Welfare Benefit Plan

This is a summary of the annual report of the Schreiber Foods, Inc. Welfare Benefit Plan, EIN 39-1017450, Plan No. 501, for period 01/01/2024 through 12/31/2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Schreiber Foods, Inc. has committed itself to pay certain self-insured Medical, Dental and Short-term Disability claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with CuraLinc, LLC, dba CuraLinc Healthcare, Vision Service Plan, Federal Insurance Company, Four Ever Life Insurance Company, Lincoln National Life Insurance Company and The Lincoln National Life Insurance Company to pay Medical, Vision, Life Insurance, Long-term Disability, Employee Assistance Program, Business Travel Accident, Critical Illness and Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2024 were \$5,363,251.
